Events

Open: Mens Singles, Womens Singles, Mens Doubles, Womens Doubles, and Mixed Doubles. Open to players of any age. Cash Prizes totaling \$1000+ awarded to Open event finalists.

Seniors: 30+, 40+, 50+, 60+ in Mens Singles, and Womens Singles.

Players must be at or over the specified age on Dec. 1st, 2006.

Combined Age: 70 (min age 25), 80 (min age 30), 90 (min age 35), 100 (min age 40), 110 (min age 45), 120 (min age 50), 130 (min age 55), in Mens Doubles, Womens Doubles, and Mixed Doubles.

The **combined age** of the doubles pair must be **at least** 70, 80 *etc.* on Dec. 1st, 2006, and **both players** must be the specified minimum age (25, 30 *etc.*) **or older** on Dec. 1st, 2006.

Limit of four events per player. No more than two Singles, Doubles or Mixed Doubles events per player.

Entry deadline: Friday 1st December

Entry fees: \$15 per person per event. Checks should be made payable to Golden Gate Badminton Club. Each player in a doubles partnership must submit separate entry forms.

Entries must be submitted through one of the following methods before the entry deadline:

- a) Form and check mailed to Chris Lawrence, 8950 Bradwell Place #104, Fishers, IN 46038.
- b) Form and check delivered in person to Golden Gate Badminton Club.

Conditions:

1. Prizes will be awarded to the winners and runners-up in all events, including \$1000 in cash prizes to the finalists of the Open events.
2. All matches will be the best of three games to twenty one points using rally-point scoring.
3. Competitors must provide their own shuttles.
4. A player not ready to play ten minutes after his / her match is called may be defaulted.
5. Acceptable badminton clothing must be worn during play.
6. Each player in a doubles partnership must submit separate entry forms.
7. Senior age events are open to players who are of the specified age or older on December 1st, 2006.
8. For the Combined Age events, the two players in the doubles partnership must satisfy the following conditions:
 - a) their combined age must meet or exceed the designated age (70, 80, 90 *etc.*) on December 1st, 2006.
 - b) the individual ages must meet or exceed the specified minimum age (25, 30, 35 *etc.*) on Dec. 1st, 2006.
9. Checks must be enclosed with entries and received by Friday 1st December. No telephone, FAX or e-mail entries will be accepted. **NB: No entry and check by Friday 1st December = no play.**
10. Entries will not be refunded if canceled less than forty-eight hours before play commences.
11. The tournament committee reserves the right to change any of the above conditions.
