**EVENTS** 

Boy's Singles, Girl's Singles, Boy's Doubles, Girl's Doubles and Mixed Doubles. Age Division: UNDER-9, UNDER-11, UNDER-13, UNDER-15, UNDER-17, UNDER-19 AND UNDER-22. To qualify for an age division, the player's age must be under the age division as of 12/31/02. A feed-in consolation draw through the quarter-finals will be used in accordance with USA Badminton. Events with less than three entries will be cancelled.

THE 2002 U.S. JUNIOR NATIONALS WILL USE THE INTERNATIONAL BADMINTON FEDERATION SCORING SYSTEM OF 3 OUT OF 5 GAMES TO 7 POINTS PER GAME (5 X 7 SCORING). FOR COMPLETE RULES, PLEASE LOG ON TO OCBADMINTONCLUB.COM OR CONTACT TIM MANGKALAKIRI AT (714) 639-6222.

**ELIGIBILITY** 

Participation in the 2002 K & D Graphics U.S. Junior National Badminton Championships is open to any member of USA Badminton (non-members may join before tournament), who are U.S. citizens or have been a resident of the United States for the last 12 months consecutively. To enter, contestants must complete this application and forward it, along with the appropriate fees, to the Orange County Badminton Club, postmarked no later than May 26, 2002 (NO TELEPHONE ENTRIES ACCEPTED. FAXED ENTRIES ACCEPTED ONLY WITH CREDIT CARD NUMBER). Entrants must also send a copy of their birth certificate or passport (no driver license, social security card or identification cards accepted).

**FEE** 

The entry fee for one event is \$50, which includes a tournament t-shirt, free tournament shuttlecocks provided by Yonex Corporation and an invitation to the tournament banquet. Each additional event is \$25 (three events max). A \$25 damage deposit is also required to cover any damage to the facility and will be returned to each participant if no damage occurs. Fee for additional banquet tickets on June 29, 2002 is \$15 per person. RSVP by June 26, 2002; banquet tickets will be unavailable after June 26th. Make checks payable to "Orange County Badminton Club".

LATE ENTRIES WILL BE CHARGED \$10. USA BADMINTON RESERVES THE RIGHT TO REFUSE LATE ENTRIES.
